2. **Document Downloading & Submission:** Bidders may download the bidding documents and submit their bids electronically through PPMO e-GP portal www.bolpatra.gov.np/egp. Bidders submitting their bid electronically should deposit the cost of bidding document as specified in the e-GP system.

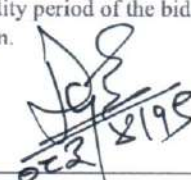
3. **Pre-Bid Meeting:** Pre-bid meeting shall be held at Mathagadhi Rural Municipality, Office of the Rural Municipal Executive, Jhadewa, Palpa on 2026-08-14 at 12:00 PM.

4. **Bid Submission Deadline:** Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before 12:00 PM on 2026-08-25. Bids received after this deadline will be rejected.

5. **Bid Opening:** The bids will be opened in the presence of Bidders' representatives who choose to attend at 01:00 PM on 2026-08-25 at the office of Mathagadhi Rural Municipality, Jhadewa, Palpa.

6. **Bid Security & Validity:** Bids must be valid for a period of 90 days from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs. 50,000.00, which shall be valid for 30 days beyond the validity period of the bid (i.e., until 2026-12-23).

7. **Government Holiday Notice:** If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case, the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
